## **Implementation Update**

### **Voluntary Assisted Dying Implementation Leadership Team - Communique March 2021**

#### ***Message from the Chair, Dr Scott Blackwell***

*The work of each ILT workstream is now well advanced; the many aspects of voluntary assisted dying required for implementation are nearing completion and our work is on track to meet the planned 1st July start.*

*We have remained person centred throughout the implementation process; always focusing on the Western Australian person who will be eligible and who will access voluntary assisted dying. To establish an accessible and safe program for that person has required us to seek a wider focus to include all who will be involved in, or affected by, voluntary assisted dying.*

*Families and friends will need information, support and referral for quality grief counselling where required.*

*The clinicians, Care Navigators, pharmacists and others who will play a key role in voluntary assisted dying will have high quality education and training as well as opportunities for good support.*

*The Board (supported by its Secretariat) is being formed to oversee voluntary assisted dying and to maintain compliance, safety and access to this end-of-life choice.*

*The broader community of clinicians and health workers across the state are being encouraged, through information and education opportunities, to understand what voluntary assisted dying may mean in their practice and be prepared for the possibility that a patient may one day raise the question of voluntary assisted dying with them.*

*We have also been reaching out to the broader health community, both private and public, with the aim of supporting them to be prepared.*

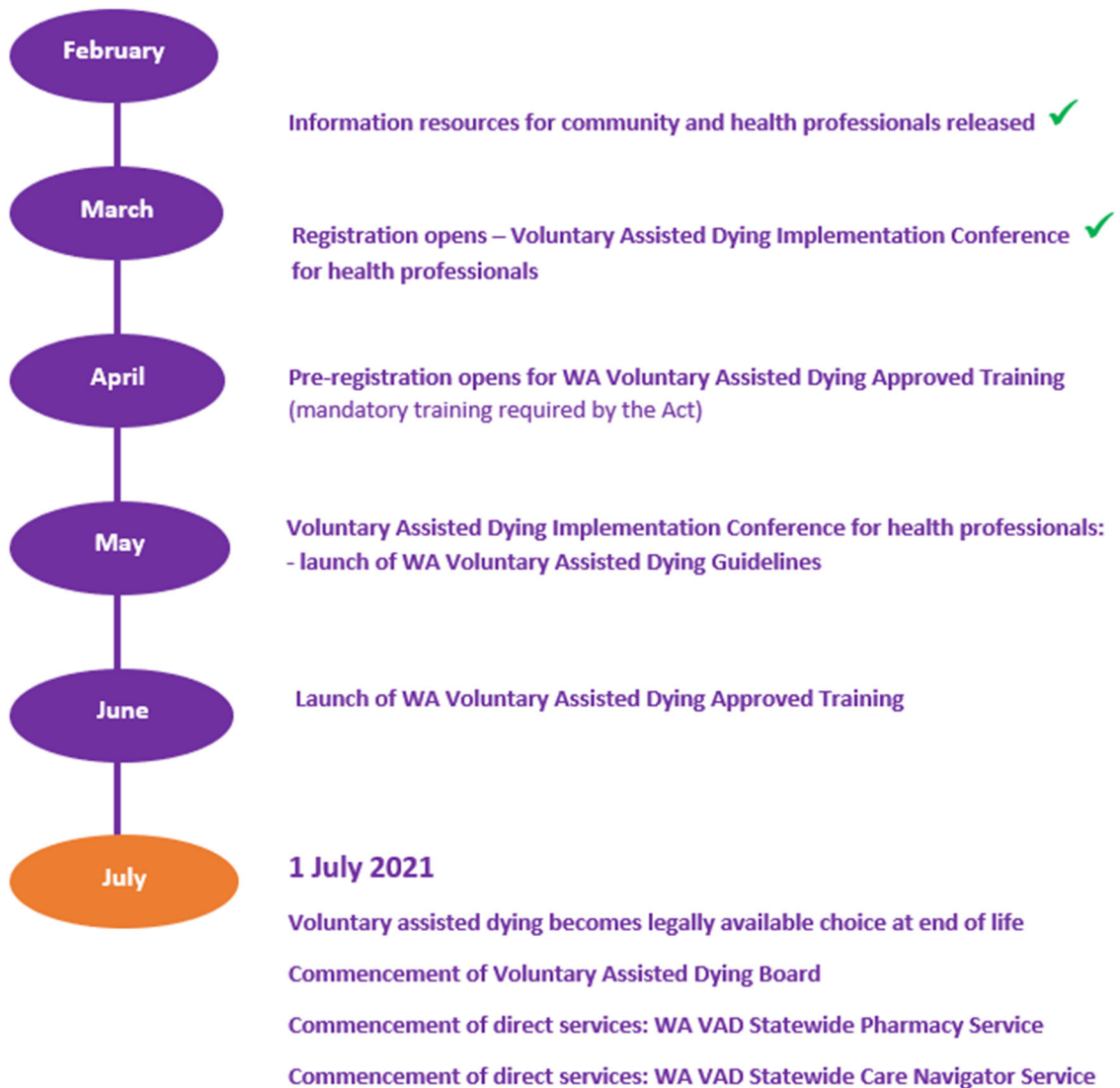

## **Information for Health Service Providers**

The Department of Health has been meeting regularly with private and public health service providers to support their preparation for the introduction of voluntary assisted dying. These services have been provided with information and guidance to support the development of policies and procedures for voluntary assisted dying prior to 1 July 2021.

## **Update on statewide services**

From 1 July 2021, Western Australians will have access to the Western Australian Voluntary Assisted Dying Statewide Pharmacy Service and the Western Australian Voluntary Assisted Dying Statewide Care Navigator Service.

### ***Western Australian Voluntary Assisted Dying Statewide Pharmacy Service***

The Western Australian Voluntary Assisted Dying Statewide Pharmacy Service (SWPS) has been established to ensure the voluntary assisted dying substance is provided in a safe, equitable, and patient-centred manner. The SWPS continue preparations for operationalisation of this service for 1 July 2021. ## **Western Australian Voluntary Assisted Dying Statewide Care Navigator Service**

The Western Australian Voluntary Assisted Dying Statewide Care Navigator Service (SWCNS) has been established to support anyone involved with voluntary assisted dying in WA. Preparations continue in the lead up to 1 July 2021 including the recent appointment of the SWCNS Clinical Nurse Consultant. Recruitment of the Care Navigators is also nearing completion.
