<b>Admission criteria</b>	Progressive life-limiting disease (malignant or non-malignant) requiring specialist consultation and/or symptom management and support.
<b>Referral process</b>	<ul style="list-style-type: none"><li>■ All referrals require the consent of the patient</li><li>■ Completion of <i>Regional Palliative Care Service Referral form</i></li><li>■ <b>Urgent referrals by phone call</b> to Clinical Nurse/Nurse Manager followed up with completion of <i>Regional Palliative Care Service Referral form</i>.</li></ul>
<b>Palliative care discharge criteria</b>	Based on discretion of the Palliative Care team and in discussion with the GP, primary team, the patient and their family/carer
